Early Voting Locations

Asheboro: Randolph County Board of Elections Office 1457 N. Fayetteville St., Asheboro, NC

Archdale: Archdale Community Services Building 213 Balfour Dr., Archdale, NC

Franklinville: Franklinville United Methodist Church 227 West Main St., Franklinville, NC

Randleman: Randleman Community Center 144 W. Academy St., Randleman, NC

Early (One-stop) Voting Hours

Thursday, Feb. 13 - Friday, Feb. 28
Monday - Friday only, 8:00am - 7:30pm

Saturday, Feb. 29
(this will be the only Saturday open for Early Voting) 8:00am - 3:00pm

Hours are the same at all Early Voting locations. You may vote at any of the four locations during Early/One-stop voting.

Your last chance to vote in the Primary will be on Tuesday, March 3, 2020 at your polling place

The polls will be open from 6:30am to 7:30pm on March 3rd

To find your polling place for March 3rd, visit RandolphCountyNC.gov/Departments/Elections and click on **Where do I vote?** under **REGISTRATION**

Unlike on Election Day, you can same-day register and vote at Early Voting (Feb. 13th - Feb.29th)

But you must be registered to vote in Randolph County by Friday, Feb. 7th if you plan to vote on Tuesday, March 3rd (Election Day)

KNOW YOUR RIGHTS

You have the right to take a marked sample ballot (like this document) in hand or on a cell phone into the voting booth to use as a reference.

If any problem arises, you have the right to vote with a provisional ballot.

If you have a disability or difficulty reading the ballot, you have the right to receive assistance from a family member, friend, or poll worker.

You will NOT be required to show a photo ID to vote in the primary due to a court-ordered injunction.
