Absentee Voting to Increase

Due to the pandemic, we should see an increase in mail-in ballots for the November election. Absentee ballots make up 3.5% of the vote during a normal year. This year they're expected to increase to 20-50% of the vote. We need to spread the word that if voters are concerned about voting in person, they can mail in an absentee ballot request beginning now for the November election. Earlier will be better than later this year.

Any registered Randolph County voter may request an absentee ballot. At <http://www.randolphcountync.gov/Departments/Elections/Absentee-Voting> you will find all the information you need, including the paperwork that must be filled out and mailed back in order to receive an absentee ballot.

The ballots are not printed yet, but you can get on the list to receive one. Proposed legislation may make the process easier as the November election approaches.

Now more than ever it is important that the post office be able to function seamlessly and without interference. Statement from Scott Huffman

Scott Huffman is running for US House District 13, against Ted Budd. Here is his message:

The Money Side of this Pandemic

I have talked with voters in the 13th Congressional District since this pandemic started, many from Randolph County. I appreciate every single Democrat, Republican, and unaffiliated voter who has given me suggestions and feedback.

As we enter phase two of Gov. Cooper's outlined response to the pandemic, I understand the stress and anxiety many of you are facing and the economic impact this pandemic has caused. As a small business owner with a wife and three kids, I feel your stress because it is the stress my family and I live with every day. These are uncertain times.

Statement from Susie Scott

Susie Scott is running for NC House, District 70 against Patricia Hurley. Here is her message:

As we gradually open up, we need to protect each other. When I'm out of my home and car, I carry hand sanitizer, wear a mask, and stay six feet away from others. Our county and state health departments and the CDC agree that we protect each other by staying home when possible and following the three W's when we are out and about: wear a mask, wait six feet back, and wash your hands often. We should also consider people working during this pandemic. They are working to put food on their table (and often yours). Protect them by respecting guidelines on their signs and websites in addition to the three W's.

Over the past month, Randolph County has seen an increase in cases. First, let me commend those businesses who are requiring their employees to wear masks and enforcing safe distancing. As a customer, I appreciate that. Thank you! But some businesses are not providing personal protective equipment. Others are not requiring that their employees wear it. If they, or members of their family, gets sick, many employees here cannot afford health insurance, and it is not offered for some jobs.

Our legislature has failed to expand Medicaid coverage even for those affected by COVID-19. This hurts our workers and it also hurts our local hospital forcing them to absorb the cost for uninsured patients who cannot pay for their treatment. Our working families who earn between 80% and 130% of the poverty level deserve access to affordable medical insurance. And our taxpayers have already paid for that coverage even though our current legislators will not let us benefit from it. That they would deny that coverage in the middle of a pandemic speaks volumes about their priorities.

In conclusion, I would like to give a shout out to Our Daily Bread, our school systems, the Randolph County Senior Center, and other nonprofits who have been providing meals for people in need during the pandemic. Stay safe out there, be kind, and look out for each other.

Survey Results

A poll published on RCDP's Facebook page on May 19th asked: "Who do you trust to phase in reopening in Randolph County? Governor Cooper or the Randolph County Commissioners?" There were 37 responses to the question. Of the 37 responses, only one person, identifying as a "progressive Democrat," indicated they would trust the Randolph County Commissioners rather than Governor Cooper. Twenty of those responding identified as "progressive Democrats," eight as "moderate Democrats," one as "middle of the road," two as "unaffiliated," two as "having nothing in common with either Democrats or Republicans," and one as a "health professional." Three did not comment.
